

ONLINE PRIVACY POLICY AGREEMENT

This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Our Policy has been designed and created to ensure those affiliated with PRP Concepts, Inc of our commitment and realization of our obligation not only to meet, but to exceed, most existing privacy standards.

Why We Collect Information and For How Long

We are collecting your data for several reasons:

The length of time we retain said information will be determined based upon the following criteria: the length of time your personal information remains relevant; the length of time it is reasonable to keep records to demonstrate that we have fulfilled our duties and obligations; any limitation periods within which claims might be made; any retention periods prescribed by law or recommended by regulators, professional bodies or associations; the type of contract we have with you, the existence of your consent, and our legitimate interest in keeping such information as stated in this Policy.

Use of Information Collected

PRP Concepts, Inc does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

PRP Concepts, Inc may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you from prpconcepts.com

PRP Concepts, Inc may also be in contact with you with regards to completing surveys and/or research questionnaires related to your opinion of current or potential future services that may be offered.

PRP Concepts, Inc uses various third-party social media features including but not limited to LinkedIn and other interactive programs. These may collect your IP address and require cookies to work properly. These services are governed by the privacy policies of the providers and are not within PRP Concepts, Inc's control.

Disclosure of Information

- to outside auditors who have agreed to keep the information confidential;
- as necessary to enforce the Terms of Service;
- as necessary to maintain, safeguard and preserve all the rights and property of PRP Concepts, Inc.

Non-Marketing Purposes

Notice to European Union Users

Security
